



Playing tickets expire at the end of each financial year and cannot be carried over. All fees are due for settlement by no later than 30 June 2024. Any change to your membership category, ancillary options or prepaid playing cards must be submitted in writing to the Club's membership department by no later than 15 June 2024 (membership@royaljhb.co.za). Similarly, should you wish to resign your membership with the Club, this too needs to be done in writing and submitted to the membership manager by 15 June 2024. Should the Club not receive a written instruction, your membership subscription will be automatically renewed.

Subscription fees: These will increase by an average of 8,8%. Any voluntary donations made to the Club by Honorary or Life members would be gratefully appreciated in assisting the Club's progression.

Member Green fees: These will increase by an average of 6.5%.

Playing tickets: All member rounds will be 'zeroed' at the start of the new financial year (1 July 2024). Members wishing to purchase a playing ticket for the new financial year, will be required to submit the request in writing, with their membership renewal (see requirement form attached).

SETTLEMENTS

Please note that incentives are not applicable when paying via the monthly debit order option. The Club is a 'cashless' environment and has the following payment options available with no other 'special' payment arrangements:

Your pro forma invoice is available immediately on request and will mirror your current subscription set up OR this will be distributed to you automatically on 12 June 2024. Once your payment has reflected, the tax invoice will then be generated and sent shortly thereafter, but not before the start of the new financial year (1 July 2024). Upon settlement of your annual fees, you acknowledge being bound by the Club's Constitution, its' rules, regulations, policies and by-laws per the terms and conditions stipulated. It is important to note the provisions of the Constitution and that your membership is an annual fee/commitment for the period 1 July 2024 – 30 June 2025.

The Club also offers a monthly debit order payment option at R75 per month. Should you choose to resign your membership with the Club during the course of the period, you will still be liable for all payments until the end of the membership year (30 June 2025).

Upon settlement of your 2024/2025 subscription, you are liable for the subscription category of choice. A member cannot downgrade or change category through the financial year as this can negatively affect the budget of the Club and its' business model. However, special requests may be addressed to the Board should you face 'serious' health issues, immigration or any other substantial reason to downgrade your subscription category. If you wish to upgrade your membership category, this can be done at any stage on a pro rata basis. Should you wish to change your membership category, this needs to be done in writing by 14 June 2024.

PLEASE BE VIGILANT


As the Club's membership renewal gets underway, we would like to advise members to please be vigilant regarding email scams.

The Club takes information security very seriously and we therefore advise members to please be aware, to prevent any 'Phishing' and to help protect our common interests.

'Phishing' is the attempt to acquire confidential information, often for malicious reasons, by impersonating a trustworthy individual in an email message. Phishing is thought to be one of the most dangerous methods of cybercrime because it is very difficult to be detected by antivirus software programs. Emails often appear harmless since they look like they are being sent from a company's email domain. Here are a few precautions to take:

- Confirm the sender's identity (email address) before replying to email requests and before opening attachments or clicking on links, even if they appear to come from a legitimate source.
- Consult your IT provider about any phishing attempts.
- Rather be safe and call us to validate communications originating from the Club.
- The Club's banking details have not changed and are available in the Annual Renewal Advice.
- Please double check all information before releasing your payment.
