THE COURSES

The Championship East Course

Designed in 1939 by Robert Grimsdell, the course is regarded to be in the top echelon of courses on the continent. After completing a full revamp in 2017, the course is now regarded as a contemporary parkland, delivering more of a challenge for the serious player as well as changes that ensure the club golfer enjoys their round. All this with emphasis on cost-effective maintenance and a fusion of environmental sensitivity with elevated aesthetic appeal.

From 2018 to 2025, the East course has received numerous international accolades including two World Golf Awards (South Africa's best course & Africa's best course), Golf Scapes Top 100 Courses in the world (25) and Course of the Year by Luxury Travel Guide.

The Royal West Course

Designed in 1927 by Laurie Waters, the West Course, shorter in comparison to the East Course, is a fine example of how two layouts in close proximity can still create quite different, but vastly enjoyable golf experiences. The West Course had a greens refurbishment in 2022 and the greens are amongst the best in South Africa.

While its beautiful sweeping fairways and generous sized greens inspire joy and confidence, the player who strays from them will quickly find trees, water or frustration in uncompromising abundance. Players of every level will find much delight in and many reasons to return.

Waterways Levy:

Due to the incredible increase in storm water from the changing weather and urban growth golf courses are facing huge challenges with maintaining waterways. The upgrade our waterways to ensure long term sustainability we have unfortunately had to implement a levy per round of golf, effective February 2026. Once we have achieved our required funding this levy will be removed. We sincerely appreciate your understanding and support.

- **Full course rate:** R3 500.00 per course
- **Group rate:** R30.00 per player

Golf days are available from Monday to Friday, subject to availability. We can accommodate small groups on Saturday & Sunday afternoons, subject to availability.

CARTS

We have 75 premium golf carts available for hire, each equipped with GPS to assist players with course navigation. Carts can be charged either to the master account or to individual player accounts. As availability is limited, we recommend booking in advance to avoid disappointment.

Cart hire fee: R550 per cart.

Additional carts may be hired externally; however, these are subject to advance booking, particularly during peak season, and are available at a higher cost. Please note that the Club applies a 10% handling fee to all externally sourced carts.

To further enhance the player experience, beverages may be added to the cooler boxes on the carts. Pricing is available upon request.



CADDIES

The Club recommends one caddy per four-ball to assist with pace of play and course management.

- The minimum caddy fee is R400, plus a Caddy Foundation fee of R80.
- The Caddy Foundation fee includes the caddy's lunch and benefits.
- Caddy fees may be charged to your account or to the players' own accounts.
- If the Club arranges cash for the caddy fee, a 10% cash-handling fee will apply

REGISTRATION

We will greet your golfers at the bag drop-off, attach name tags to each golf bag, and transport bags to either carts or caddies based on each golfer's selection.

Golfer registration can be set up either in the reception foyer or on the patio. We will provide tables as needed for gifting and materials, and you are welcome to brand the registration area to suit your event.

A variety of arrival snack options are available in our menu pack for your consideration.

SCORING AND MARSHALLING

We are pleased to offer a complimentary scoring and marshalling service, complete with a customized prize sheet tailored to your event's requirements.

For those interested in electronic scoring, we can provide Score Capture, which enables golfers to view live leaderboards in real time throughout the event.

BRANDING

Banner Handling Fee: R 6,500.00

We will assist with up to 4 banners at no cost, thereafter the above banner handling fee applies.

This fee is non-negotiable and includes:

- Gate 8 Access: Use of Gate 8 for transporting branding materials and displays (including vehicles) to designated areas on the course. This gate is secured and monitored by security personnel.
- On-Course Supervision: Our team will oversee and guide all branding setup, even if external staff or sponsors assist, to ensure the course remains undamaged.
- Setup & Breakdown Support: Coordination and assistance with branding logistics before and after the event.

Branding terms & conditions:

- Approved branding locations include registration areas, the putting green, around the clubhouse, and specific holes as agreed.
- Banners may only be put up on the day of the Golf Day.
- All branding/banner bags must be clearly labeled with their assigned hole.
- No banners may be left on the course overnight.
- Royal Johannesburg accepts no liability for loss or damage to goods, banners, or banner bags.
- All items must be removed immediately after the event unless alternative arrangements have been made.
- Items not collected within 7 (seven) days will be retained by Royal Johannesburg and may be discarded or donated to a local charity.

Vehicles and Equipment:

Limited access to certain holes is available for displaying vehicles and equipment. Please contact us to discuss your requirements and the strict rules that apply.

LIGHTNING POLICY, RAIN, DISCONTINUANCE OF PLAY

Club Safety Policy During Inclement Weather

The safety of our members and guests is our highest priority during adverse weather conditions. Weather reports and local conditions are closely monitored during storm warnings. If it is determined that continuing play is unsafe due to an approaching storm, the siren will sound, and all golfers must immediately leave the course and return to the clubhouse.

In the event of a lightning threat, play will be suspended—continuing at your own risk is not permitted. Under the rules of golf, players are allowed to stop play at any time if they feel endangered.

When lightning is detected, the following sirens will apply:

- **One long blast** - Stop play immediately and return to the clubhouse.
- **Two shorter blasts** – Resume play

Should the course be rained out for any reason the following allowances will apply :

- Before players tee off , if management deem the course to be unplayable, a raincheck will be given for a future available date. Any costs that are not recoverable (eg. external cart hire, F&B) will be payable.
- If players have not completed 9 holes and play is not able to resume for the day the club will provide each player with a 9 hole raincheck voucher.

WATERING HOLES

We offer a drinks cart that can be operated either on the main account (within your specified budget) or on individual players' accounts. Additionally, you can set up refreshment stations on the course, where we can provide beverages, ice, and containers at Club prices according to your requirements.

Alternatively, you may bring your own beverages and snacks, subject to a corkage fee of **R2,500** per hole.

We will provide a table and two chairs per hole.

We recommend a maximum of two watering holes per nine holes. Details regarding watering holes and sponsored holes must be submitted at least two weeks in advance.

Please also ensure that non-alcoholic drinks are available for caddies when planning your refreshments.

Dress Code & Club Guidelines

Dress Code:

Golf course: Collared shirts, tailored pants (no jeans), and soft-spike golf shoes.

Clubhouse: Smart casual or golf attire (no vests).

Golf Equipment:

All golfers must use their own clubs. Limited sets of rental clubs are available through our Pro Shop.

Mobile Phones:

Phones should be set to silent and must not disrupt the pace of play.

Club Rules & Conduct:

All club rules, whether displayed on-site or listed on our website, apply to all guests.

We encourage everyone on our property to interact with staff and fellow golfers in a respectful and courteous manner.

Golf Etiquette:

Players should follow standard golf etiquette, including repairing pitch marks, raking bunkers, filling divots, and keeping carts away from tees and greens.

The Club will exercise reasonable care at all times; however, it shall not be liable for any claims, damages, or losses of any kind arising from the use of the Club's facilities or services by members or their guests.

The Club accepts no responsibility for loss of life, theft, or damage to cash, personal belongings, clothing, golf clubs, valuables, equipment, or any other property, nor for any damage to vehicles in the car park or surrounding public areas. The Club is also not liable for any injury or harm to any person while on Club premises.

BOOKING TERMS AND CANCELLATIONS

Booking and Payment Terms

- To secure your booking date, a 50% deposit of greenfees and a signed booking sheet are required.
- Final guest numbers must be confirmed 14 days prior to the event.
- The remaining balance including expected F&B cost is due 7 days before the event.
- Any incidentals incurred on the day must be settled within 7 days of receiving the final invoice.

Cancellation Policy

- More than 90 days' notice: 100% refund of deposit.
- 45–90 days' notice: Loss of deposit.
- 30–44 days' notice: 50% of total green fees.
- Less than 30 days' notice: Full green fees payable.

Please note: Once final numbers are confirmed (14 days prior to the event), you will be liable for the full invoice, including all food and beverage charges.
